

RUGANI JUICE COMPETITION

TERMS AND CONDITIONS (T'S & C'S)

1. The "Promoter" is Rugani Juice, a brand of Greenway Farms.
2. Competition entry requires the purchase of any Rugani Juice regardless of pack size or flavour.
3. By entering this competition, an entrant indicates his/her agreement to be bound by these terms and conditions.
4. The competition runs from 17 February to 31 May 2025, and the closing date for entry will be 31 May 2025. After this date, no further entries in the competition will be permitted.
5. The competition and these terms and conditions will be governed by South African law, and any disputes will be subject to the exclusive jurisdiction of the courts of South Africa.

6. Participants

- 6.1 The competition is open to residents of South Africa aged 18 years or over, except employees of the Promoter, their close relatives, and anyone otherwise connected with the Promoter, their advertising and promotional agencies, or judging of the competition.
- 6.2 To qualify as a valid entrant, you need to:
 - 6.2.1 Buy any Rugani Juice.
 - 6.2.2 Take a picture of your purchase slip.
 - 6.2.3 Scan the QR code and send your slip or message "RUGANI" to 071 253 4690
- 6.3 Incomplete entries will be disqualified.

7. Permissions and Rules

- 7.1 1 (one) slip equates to 1 (one) entry.
- 7.2 If you have won a Rugani Juice competition within the past 30 days before the opening date of this competition, you will unfortunately not qualify as a winner.
- 7.3 The winner agrees to the use of his/her name and image in any publicity material, as well as their entry. Any personal data relating to the winner or any other entrants will be used solely in accordance with the current POPI Act and will not be disclosed to a third party without the entrant's prior consent.
- 7.4 The winner agrees to disclose their delivery details upon winning the competition for stock to be delivered.

8. Prize Draw

- 8.1 The prize is as follows:
 - 8.1.1 1 (one) person will win a (six) month's supply of Rugani Juice each week for 16 (sixteen) weeks.
 - 8.1.2 This equates to approximately 18 (eighteen) cases of Rugani Juice, which amounts to 180 (one hundred and eighty) 330 ml Rugani Juice cartons.
 - 8.1.3 The prize is not transferrable for cash.
 - 8.1.4 Once contacted, the winner and the Promoter will agree on flavours to be provided for the next 6 months. The Promoter reserves the right to provide flavours at its sole discretion.
 - 8.1.5 The prizes will be delivered to the winner as a once-off shipment to an address (in South Africa) of the winner's choosing.

- 8.3 The winner will be notified by phone within 28 days of the closing date. If the winner cannot be contacted or does not claim the prize within 14 days of notification, we reserve the right to withdraw the prize from the winner and pick a replacement winner.
